EACH YEAR THE CENTER SERVES APPROXIMATELY 100 CHILDREN WHO ARE BLIND OR VISUALLY IMPAIRED AND PROVIDES AN ARRAY OF SUPPORT SERVICES FOR MORE THAN 350 FAMILY MEMBERS. OUR GOAL IS TO OPTIMIZE EACH CHILD'S DEVELOPMENT AND OPPORTUNITIES TO LEAD A MEANINGFUL LIFE THROUGH A COMPREHENSIVE PROGRAM BEGINNING WITH EARLY INTERVENTION, FOLLOWED BY AN EDUCATION CURRICULUM SPECIFICALLY ADAPTED TO THE NEEDS OF EACH STUDENT.
